- 1. Candidates should ensure that public funds, resources and facilities are not used for campaigning.
- 2. Candidates should adhere to the Election Offences Act 1954 and regulations, including, but not limited to, Election Spending Limits and vote buying regulations.
- 3. Candidates and elected representatives should ensure that their actions and decisions are for the benefit of the general public and are not self-serving. They should practise transparency and openness through full disclosure to and free access to information by the public.
